1. Statutory Workers' Compensation Insurance in compliance with the laws of the State of New Jersey and Employers Liability Coverage in the amount of \$1,000,000 each accident/ each employee/ each disease.
2. Comprehensive General Liability and Bodily Injury Insurance including death in the amount of \$1,000,000 for each occurrence and \$2,000,000 in aggregate. TTHMUA shall be named as an additional insured.
3. Comprehensive Automobile Liability, Bodily Injury, Property Damage Insurance with a limit of no less than \$1,000,000 Combined Single Limit. TTHMUA shall be named as an additional insured.
4. Excess Liability policy with limits of liability not less than \$5,000,000, with drop-down provision included. This must be in excess of all primary liability contracts. When the required underlying limits of excess carrier are less than those required by these specifications, the lower underlying limits will be acceptable. TTHMUA shall be added as an additional insured.
5. Professional Liability Insurance for \$5,000,000 per claim and annual aggregate.

In addition to the required documentation contained herein, a certified check, cashier's check or bid bond issued by a responsible bank, trust company or insurance company, payable to The Township of Hillsborough Municipal Utilities Authority shall be submitted with each bid as a guarantee that if a contract is awarded the Bidder shall execute said Contract and furnish the bond required by the Contract Documents. The Bid Security shall be in the amount of ten percent (10%) of the total amount of the bid or Twenty-Thousand Dollars (\$20,000), whichever is lower.
