PLEDGE OF ALLEGIANCE

UPDATE FROM VNHA:

Engineering Consultants for the Sunnymeade Project provided an update. Mr. Hough reported that the letter was sent to SRVSA and they (SRVSA) advised they would reply, but nothing has been received as of yet.

At 6:12 and Peter Cipparulo, III, Esq., General Counsel arrived.

Mr. Brandon Fetzer provided updated information on flow capacities for the trunks at Roycebrook, relative to the pipes connections and flow (capacity of the new pipe) the issue is that the closer you get to the Sunnymeade pump station the more constricted the flow will be as a result of the mechanics of the pipe structure. They have analyzed the main section and the next step is to look at it on a development level.

Mr. Hough inquired that if we were to do dry weather metering, how quickly would the meters get dropped?

Mr. Fetzer advised they are scheduling approximately one week out.

Mr. Nunn inquired about utilizing existing Sunnymeade pump meters?

Mr. Hough recommended utilizing the vendor.

Mr. Brandon Fetzer explained that it would be a broader assessment of the system and showed a map of where the meters would be potentially placed.

Mr. Nunn asked VNHA to provide a proposal for said project.

Mr. Hough advised that Flow Assessments provided a proposal for the meters and the data, VNHA will need to provide a proposal for the analytical work.

At 6:24 Donald Fetzer, P.E., Brandon Fetzer, P.E., and Agha Hasan, P.E. all of Van Note Harvey Associates, Inc., TTHMUA's consulting engineer for the Sunnymeade project left the meeting.

Further discussion ensued among the Board members regarding this matter. Mr. Scarantino added that flow metering is a good idea for a baseline of information, but would like a total proposal for the entire cost of the proposed project.

Mr. Hough reported that he has the proposal for the metering and will share with the board.

Mr. Nunn inquired if Mr. Hough could provide analysis of the data obtained from the flow meters.

RESOLUTION # 22-0831-1 – Resolution Appointing CME Associates, Inc. as Professional Engineer for The Township of Hillsborough Municipal Utilities Authority (TTHMUA)

WHEREAS, there exists a need for Professional Engineer Services to The Township of Hillsborough Municipal Utilities Authority (TTHMUA); and

WHEREAS, TTHMUA has determined and certified that the value of the contract will not exceed \$17,500; and

WHEREAS, funds are available for this purpose, and

WHEREAS, the "New Jersey Pay to Play" Law, (N.J.S.A. 19:44A-20.4 et seq) requires that the resolution authorizing the award of contracts for "Professional Services" thru the 'Fair and Open' Process was publicly advertised.

NOW, THEREFORE, BE IT RESOLVED by The Township of Hillsborough Municipal Utilities Authority as follows:

- 2. The Executive Director shall publish a notice of award of said contract in the Courier News and Hillsborough Beacon in accordance with the provisions of the Local Public Contracts Law.
