RESOLUTION # 23-0329-1 – Resolution Authorizing the Executive Director of The Township of Hillsborough Municipal Utilities Authority (TTHMUA) to Execute an Indemnity Agreement with Mr. Frank S. Scarantino

WHEREAS, there is a need for an Indemnity Agreement be made as of by and between Frank S. Scarantino, as the person or entity receiving indemnity (hereinafter referred to as the "Indemnitee"), located at 119 Valley Road, Hillsborough, New Jersey 08844 and the Township of Hillsborough Municipal Utilities Authority (TTHMUA), as the person or entity bound to provide and / or protect the indemnitee, located at 220 Triangle Road, Suite 234, Hillsborough, New Jersey 08844.

NOW, THEREFORE, BE IT RESOLVED by The Township of Hillsborough Municipal Utilities Authority (TTHMUA), that the Executive Director of TTHMUA is hereby authorized to prepare and execute an Indemnity Agreement with Mr. Frank S. Scarantino on behalf of TTHMUA.

RESOLUTION # 23-0329-2 – Resolution of The Township of Hillsborough Municipal Utilities Authority (TTHMUA) Authorizing Additional Compensation to Mott MacDonald not to exceed \$7,500.00 to provide Additional Pump Station Upgrades Services and Concrete Testing Services Related to the Sunnymeade Pump Station Project

WHEREAS, there exists a need for Professional Engineering Services for The Township of Hillsborough Municipal Utilities Authority (TTHMUA) related to the Sunnymeade Pump Station Project; and

WHEREAS, TTHMUA has previously approved Resolutions #22-1026-2 and # 23-0201-23 for Mott MacDonald to perform various Professional Engineering Services related to the Sunnymeade Pump Station Project; and

WHEREAS, there continues to be a need for Mott MacDonald to perform additional Professional Engineering Services related to the Sunnymeade Pump Station Project; and

WHEREAS, Mott MacDonald has requested additional fees totaling \$7,500.00 for the preparation and attendance at the January 25, 2023 TTHMUA Board Meeting (fee of \$1,250.00), for the coordination and to obtain prices for concrete core testing (fee of \$3,500.00), and for concrete core testing observation and report review (fee of \$2,500.00); and

WHEREAS, TTHMUA has a need to acquire these services and is subject to the profession exemption as defined by P.L. 2004, c.19, the "Local Unit Pay-to-Play Law" and in connection therewith, Mott MacDonald has previously completed and filed with TTHMUA the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8, Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26 and TTHMUA's "Pay-to-Play Forms"; and

WHEREAS, the Local Public Contracts Law, N/J.S.A. 40A:11-5(1)(a)(i), authorizes TTHMUA to award this agreement as a Professional Services Agreement, without public bidding.

NOW, THEREFORE, BE IT RESOLVED by The Township of Hillsborough Municipal Utilities Authority (TTHMUA) as follows:

- 1. The Chairman and Executive Director are hereby authorized and directed to execute a Professional Services Agreement with Mott MacDonald for additional Professional Engineering Services consistent with this Resolution and the above "Whereas" clauses.
- 2. The agreement is awarded without competitive bidding as a professional services Agreement as authorized under N.J.S.A. 40A:11-5(1)(a)(i).
- 3. Mott MacDonald shall be paid a fee not to exceed \$7,500.00 to perform additional Professional Engineering Services related to the Sunnymeade Pump Station Project. The term of the agreement shall be one (1) year.
- 4. A copy of this Resolution, the Pay-to-Play Forms and the Agreement shall be placed on file in the TTHMUA offices.
- 5. The Executive Director shall publish a notice of award of said agreement in the Hillsborough Beacon in accordance with the provisions of the Local Public Contracts Law.

A motion was made by Mr. Scarantino, seconded by Mr. McCray and all present voted in favor of the above resolution.

RESOLUTION # 23-0329-3– Resolution Designating Additional Depositories for The Township of Hillsborough Municipal Utilities Authority (TTHMUA)

Ms. Brown advised that she has contact several local banks including: Fulton, Unity, Magyar and Kearny to find out their rates. She further provided additional information regarding the types of accounts and available rates.

Unity 3.5%

Kearney 4.2%, no transaction fees, no online banking fees, work with 3rd party vendor for credit card payments, employee programs also available. Ms. Brown provided a written summary to Mr. Hough regarding all of the information she obtained. Fulton Bank had not yet provided a response. Discussion ensued regarding the various types of accounts to be considered.

Conversation ensued regarding the type of accounts.

Mr. Scarantino advised that Mr. Peter Wozniak, SRVSA CFO was given an accommodation regarding banking services; he further inquired if Ms. Brown and Mr. Damiano could reach out directly to Mr. Wozniak. Additionally, Mr. Nunn will reach out to Mr. Anastasio, SRVSA ED.
